Mid Century Modern Architecture: The Next Great Challenge for Historic Preservationists

Using Columbus, Indiana, as the focus, this presentation will discuss the ever-increasing dilemma facing owners and architects in terms of the future use of buildings built in the 1950's – 1970's. In addition to Columbus, this presentation will include representative projects from across the nation...some successes and some failures...that dealt with iconic buildings designed by famous Modernist architects.

10 Ways to Manage Risk

Case Study: Nast Engineering

This discussion will include key points in project management focusing on contract language, inspection, stop work authority, and contract administration as well as inadequate inspection and inadequate communication.
