Moderator and Vice Moderator Message

Our work this year selected Areas of Study (AOS) which are extensions and expansions of last year's work.

- We created Areas of Impact (AOIs), for the first time, with the goal of breaking down silos between topics. AOIs align with the AIA's strategic goals (climate action and equitable communities) and are forward thinking and intended to be potential system disruptors.
- Council is actively collaborating with many Knowledge Communities along with organizations outside of the AIA in our critical thinking and research.

2021 AREAS OF STUDY

Rural + Suburban Agenda -

We established our "Guiding Principles" and have been dedicated to getting workshops scheduled involving member focus groups to identify resources and areas of need.

Abstract (WHY): DESIGN a Rural + Suburban agenda identifying resources for our members and communities within which they practice!

Mental Health -

We established our Guiding Principle statement and identified or this group as if there were "no holds barred".

Abstract: We will build a bridge between existing mental health expertise and the architecture profession.

Technology Impacting Practice (TIP) -

Abstract: To expand TIP's 2020 Summit Call to Action to a Resolution in New Ways of Practice, Delivery & Monetization.

The Challenge: We cannot rest in our quest for evolution and transformation. It is essential if we are to remain relevant in our profession.

Housing & Infrastructure -

Abstract: Create AIA pathways to support architects' reach to champion *equitable housing and communities*.

The Challenge: Demand for affordable and equitable housing is rising at a faster rate than the design and construction industry can currently meet.

2021 VISIBILITY NETWORK CALLS

The Board Continues to share information with the region via the Visibility Network calls. Tim Hawk has been sharing the updates. On May 12, he introduced Nate Hudson from Nevada who talked about CCADE (pronounced cicada, like the insect)- Committee on Climate and Design Excellence Initiative by the board. The goals is to further initiatives on net zero carbon emissions, equitable, resilient and healthy communities in reference to the Framework for Design Excellence. Goals are: 1- Develop Content 2- Be external to other groups inside and outside of AIA 3- Create Partnerships with other organizations.

Include buildings in federal infrastructure investment

THE PROBLEM

The nation's public building stock needs significant investment to meet 21st century demands.

THE ASK

AIA urges Congress to include funding for buildings in any federal infrastructure package.

The American Institute of Architects 1735 New York Avenue, NW Washington, DC 20006-5292 Building infrastructure investment must be included in any infrastructure legislation. Horizontal infrastructure (including roads, bridges, and waterways) and building infrastructure (including schools, hospitals, civic centers, and affordable housing) are two sides of the same coin. Both are critically important to our nation's economy and both are in need of significant investment.

The American public and the federal government have long recognized the important role that buildings play in our nation's infrastructure:

Public Opinion:

- 82% of Americans agree that public buildings are as important as transportation in defining community infrastructureⁱ
- 91% of all voters consider stable affordable housing "highly important" to people's security and well-beingⁱⁱ
- 75% of Gallup Poll respondents agree that the federal government should spend more to improve infrastructure, including buildingsⁱⁱⁱ
- 70% of Americans agree that public schools should be considered part of America's infrastructure^{iv}

Federal Government:

- The U.S. Department of Homeland Security (DHS) includes buildings as a component of critical infrastructure^v
- The Federal Emergency Management Agency (FEMA) includes schools and hospitals as U.S. infrastructure^{vi}
- The Cybersecurity & Infrastructure Security Agency (CISA) includes a variety of buildings within the Government Facilities Sector that are considered a Critical Infrastructure Sector^{vii}

The Solution:

Congress should ensure that any comprehensive federal infrastructure package includes at least \$300 billion for building infrastructure. To best leverage this investment for decades to come, Congress must promote energy-efficient and resilient building practices. Specifically, Congress should incentivize building code adoption at the state and local level for new construction projects, and encourage the adoption of stretch codes like the IECC 2021 ZERO Code Renewable Energy Appendix. Doing so will lower energy bills for taxpayers and the government alike and produce well-paying jobs for many Americans.
